I agree to pay all applicable interest charges on any delinquent accounts.

**DO NOT HARVEST BEFORE FIELDS ARE INSPECTED**

**I Will:**

- \*Rogue fields to eliminate off-type plants and noxious weeds whose seed are difficult to remove.
- \*Thoroughly clean all harvesting, seed handling, and storage equipment.
- \*Maintain identity of seed from these fields at all times.
- \*Prevent contamination of the seed.
- \*Process, label, and market the seed as prescribed by VCIA rules and regulations.

**I Have:**

- \*Planted an eligible class of Certified seed on eligible land.
- \*Thoroughly cleaned all equipment involved in planting prior to handling Certified seed.
- \*Provided adequate isolation distance.
